Non-voting Villages (*Kingston, Montego, Blue Anchor, Port Royale, and Mardi Gras*) have been provided with a postage-paid postcard. Please return your signed and completed postcard to help achieve the required quorum. The deadline for delivery of your completed postcard by mail (or by hand delivery to the Administrative Office) is no later than 5:00 p.m. September 9, 2020. Completed postcards may also be hand delivered to the Inspector of Elections at the Grand Caribe Room, 501 Grand Caribe Causeway on September 10, 2020, no later than 4:00 p.m.

The quorum requirement to conduct business at the Annual Meeting is 400 of the Membership. If a quorum is not met, the meeting will be cancelled. It is important that all villages participate in the count toward the quorum. The Association will not be preparing or distributing any proxies for this meeting. Therefore, it is important that your enclosed postcard or ballot arrives at the C.C.H.O.A. office by 5:00 p.m. September 9, 2020, or is hand delivered to the Inspector of Elections at the Grand Caribe Room, 501 Grand Caribe Causeway on September 10, 2020, no later than 4:00 p.m.
